 - ▶ 200 beds

Steve Hoyle Intensive Substance Abuse Program

- ▶ Males only
- ▶ Probation and Parole
- ▶ Length of program varies (up to 12 months)
- ▶ 600 beds
- ▶ Eligibility Probation – Act 402
 - ▶ Send court minutes to PNP HDQ Attn. Jennifer Bush
- ▶ Eligibility Parole – Act 402/Act 299
 - ▶ Submit violation report to PNP HDQ



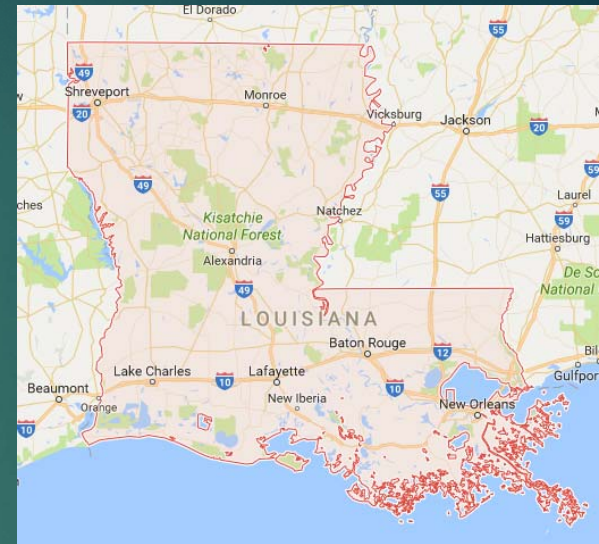
Louisiana Transitional Center for Women

- ▶ Females only
- ▶ Probation and Parole
- ▶ 36 beds per track
- ▶ Length of program 12 weeks or 9 months
- ▶ Probation Eligibility – ACT 402
 - ▶ Send court minutes to PNP HDQ Attn. Jennifer Bush
- ▶ Parole Eligibility - ACT 402
 - ▶ Submit violation report to PNP HDQ



Transitional Work Program

- ▶ Males and Females
- ▶ Probation and Parole
- ▶ Statewide
- ▶ Probation Eligibility – In Lieu of Revoc.
 - ▶ Email minutes to TWPReccomendations@corrections.state.la.us
- ▶ Parole Eligibility – In Lieu of Revocation
 - ▶ Submit violation report to PNP HDQ as normally done



Blue Walters Substance Abuse Treatment Program

- ▶ Male only
- ▶ Parole Only
- ▶ Length of program 12 weeks
- ▶ 200 beds

- ▶ Parole Eligibility – In Lieu of Revocation
 - ▶ Submit violation report to PNP HDQ



Intensive Incarceration

- ▶ Probation only
- ▶ Males and Females
- ▶ Males Bossier, Females LCIW
- ▶ Length of program up to 1 year

- ▶ Probation Eligibility – In Lieu of Revocation, Added Condition
 - ▶ Email copy of minutes to intensiveincarceration@corrections.state.la.us



Substance Abuse Probation Program ACT 389

- ▶ Probation only
- ▶ Males and Females
- ▶ Statewide
- ▶ Length of program varies case by case
- ▶ Probation Eligibility –
 - ▶ Charged with Felony Possession of CDS as defined in R.S. 40:966(C), 40:967(C), 40:968(C), or 40:969(C)
 - ▶ Charged with PWID as defined in R.S. 40:966(A), 40:967(A), 40:968(A), or 40:969(A) where the offense involves less than 28 grams
